BYLAW NUMBER 206

A BYLAW OF THE SUMMER VILLAGE OF ARGENTIA BEACH IN THE PROVINCE OF ALBERTA TO ESTABLISH A MUNICIPAL EMERGENCY MANAGEMENT AGENCY

WHEREAS the Council of the SUMMER VILLAGE of ARGENTIA BEACH is responsible for the direction and control of its emergency response and is required, under the Emergency Management Act, Revised Statutes of Alberta 2000, Chapter E-6.8, to appoint an Emergency Management Committee and to establish and maintain an Emergency Management Services Agency; and

WHEREAS it is desirable in the public interest, and in the interests of public safety, that such a committee be appointed and such an agency be established and maintained to carry out Council's statutory powers and obligations under the said Emergency Management Act;

NOW, THEREFORE, THE COUNCIL OF THE SUMMER VILLAGE OF ARGENTIA BEACH, DULY ASSEMBLED, ENACTS AS FOLLOWS:

1. This by-law may be cited as the Emergency Management Services by-law.
2. In this by-law,
 - (a) "Act" means the Emergency Management Act, Chapter E-6.8, Revised Statutes of Alberta 2000;
 - (b) "Council" means the Council of the SUMMER VILLAGE of ARGENTIA BEACH;
 - (c) "Disaster" means an event that has resulted or may result in serious harm to the safety, health or welfare of people, or in widespread damage to property;
 - (d) "Emergency Management Services Committee" means the committee established under this by-law;
 - (e) "Emergency" means an event that requires prompt co-ordination of action or special regulation of persons or property to protect the safety, health or welfare of people or to limit damage to property;
 - (f) "Gross Negligence" means an action or an omission in reckless disregard of the consequences to the safety or property of another.
 - (g) "Minister" means the Minister charged with administration of the Act;
 - (h) "Municipal Emergency Management Services Agency" means the agency established under this by-law; and
 - (i) "Municipal Emergency Plan" means the emergency plan prepared by the Deputy Director of Emergency Management to co-ordinate response to an emergency or disaster.
3. There is hereby established an Emergency Management Committee to advise Council on the development of emergency plans and programs.

4. There is hereby established a Municipal Emergency Management Services Agency to act as the agent of Council to carry out its statutory powers and obligations under the Act. This does not include the power to declare, renew, or terminate a state of local emergency, nor the powers contained in Section 13 of this by-law.
5. Council shall
 - (a) by resolution, appoint **all** of its members to serve on the Emergency Management Services Committee;
 - (b) provide for the payment of expenses of the members of the Emergency Management Services Committee;
 - (c) by resolution, on the recommendation of the Emergency Management Services Committee, appoint the County of Wetaskiwin as Director of Emergency Management and the Municipal Administrator of the Summer Village of Argentia beach as Deputy Director of Emergency Management.
 - (d) ensure that emergency plans and programs are prepared to address potential emergencies or disasters in the SUMMER VILLAGE of ARGENTIA BEACH;
 - (e) approve the SUMMER VILLAGE of ARGENTIA BEACH's emergency plans and programs; and
 - (f) review the status of the Municipal Emergency Plan and related plans and programs at least once each year.
6. Council may
 - (a) by by-law borrow, levy, appropriate and expend, without the consent of the electors, all sums required for the operation of the Municipal Emergency Management Services Agency; and
 - (b) enter into agreements with and make payments or grants, or both, to persons or organizations for the provision of services in the development or implementation of emergency plans or programs, including mutual aid plans and programs.
7. The Emergency Management Services Committee shall
 - (a) review the Municipal Emergency Plan and related plans and programs on a regular basis; and
 - (b) advise Council, duly assembled, on the status of the Municipal Emergency Plan and related plans and programs at least once each year.
8. The Municipal Emergency Management Services Agency shall be comprised of one or more of the following:
 - (a) the Director of Emergency Management;
 - (b) the Deputy Director of Emergency Management;
 - (c) the Manager, Administrator, Clerk or other administrative staff member(s) of the municipality;
 - (d) the Police Chief or designate or the N.C.O. in charge, RCMP or designate;
 - (e) the Fire Chief or designate;
 - (f) the Public Information Officer or designate;
 - (g) the Public Works Foreman or designate;
 - (h) the Ambulance Service Manager or designate;
 - (i) the Community Development Manager or designate;
 - (j) the Health Unit Manager or designate;

- (k) the Hospital Director or designate;
- (l) the Recreational Director or designate;
- (m) the School Board Chairman or designate;
- (n) the Social Services Manager or designate;
- (o) representative(s) from adjacent communities which have entered into mutual aid agreements;
- (p) representative(s) from local business or business associations (e.g. Chamber of Commerce, Board of Trade);
- (q) representative(s) from local industry or industrial associations;
- (r) representative(s) from local telephone service provider;
- (s) representative(s) from Alberta Agriculture, Food and Rural Development;
- (t) representative(s) from Alberta Environment;
- (u) representative(s) from Alberta Transportation; and
- (v) anybody else who might serve a useful purpose in the preparation or implementation of the Municipal Emergency Plan.

9. The Director of Emergency Management shall
 - (a) act as director of emergency operations, or ensure that someone is designated under the Municipal Emergency Plan to so act, on behalf of the Municipal Disaster Services Agency; and
 - (b) co-ordinate all emergency services and other resources used in an emergency; or
 - (c) ensure that someone is designated to discharge the responsibilities specified in paragraphs (a), (b), and (c).

10. The Deputy Director of Emergency Management shall
 - a) prepare and co-ordinate the Municipal Emergency Plan and related plans and programs for the SUMMER VILLAGE of ARGENTIA BEACH.

11. The power to declare or renew a state of local emergency under the Act, the powers specified in Section 13 of this by-law, and the requirement specified in Section 16 of this by-law, are hereby delegated to the Mayor, or the Deputy Mayor, alone, or in their absence, any member of Council. Declaration form attached to this bylaw as Appendix "A"

12. When a state of local emergency is declared, the person or persons making the declaration shall
 - (a) ensure that the declaration identifies the nature of the emergency and the area of the SUMMER VILLAGE OF ARGENTIA BEACH in which it exists;
 - (b) cause the details of the declaration to be published immediately by such means of communication considered most likely to notify the population of the area affected;
 - © notify Alberta Emergency Management Agency, as soon as is reasonably practicable; and
 - (d) forward a copy of the declaration to the Minister forthwith.

13. Subject to section 16, when a state of local emergency is declared, the person or persons making the declaration may
 - (a) cause the Municipal Emergency Plan or any related plans or programs to be put into operation;

- (b) acquire or utilize any real or personal property considered necessary to prevent, combat or alleviate the effects of an emergency or disaster;
- © authorize or require any qualified person to render aid of a type he or she is qualified to provide;
- (d) control or prohibit travel to or from any area of the SUMMER VILLAGE OF ARGENTIA BEACH;
- (e) provide for the restoration of essential facilities and the distribution of essential supplies and provide, maintain and co-ordinate emergency medical, welfare and other essential services in any part of the SUMMER VILLAGE OF ARGENTIA BEACH;
- (f) cause the evacuation of persons and the removal of livestock and personal property from any area of the SUMMER VILLAGE OF ARGENTIA BEACH that is or may be affected by a disaster and make arrangements for the adequate care and protection of those persons or livestock and of the personal property;
- (g) authorize the entry into any building or on any land, without warrant, by any person in the course of implementing an emergency plan or program;
- (h) cause the demolition or removal of any trees, structures or crops if the demolition or removal is necessary or appropriate in order to reach the scene of a disaster, or to attempt to forestall its occurrence or to combat its progress;
- (i) procure or fix prices for food, clothing, fuel, equipment, medical supplies, or other essential supplies and the use of any property, services, resources or equipment within the SUMMER VILLAGE OF ARGENTIA BEACH for the duration of the state of emergency;
- (j) authorize the conscription of persons needed to meet an emergency; and
- (k) authorize any persons at any time to exercise, in the operation of the Municipal Emergency Plan and related plans or programs, any power specified in paragraphs (b) through (j) in relation to any part of the municipality affected by a declaration of a state of local emergency.

- 14. When a state of local emergency is declared,
 - (a) neither Council nor any member of Council, and
 - (b) no person appointed by Council to carry out measures relating to emergencies or disasters,
 - is liable in respect of damage caused through any action taken under this By-law, nor are they subject to any proceedings by prohibition, certiorari, mandamus or injunction.
- 15. Notwithstanding Section 14,
 - (a) Council and any member of Council, and
 - (b) any person acting under the direction or authorization of Council,
 - is liable for gross negligence in carrying out their duties under this By-law.
- 16. When, in the opinion of the person or persons declaring the state of local emergency, an emergency no longer exists in relation to which the declaration was made, they shall, by resolution, terminate the declaration.
- 17. A declaration of a state of local emergency is considered terminated and ceases to be of any force or effect when
 - (a) a resolution is passed under Section 16;
 - (b) a period of seven days has lapsed since it was declared, unless it is renewed by resolution;

- © the Lieutenant Governor in Council makes an order for a state of emergency under the Act, relating to the same area; or
- (d) the Minister cancels the state of local emergency.

18. When a declaration of a state of local emergency has been terminated, the person or persons who made the declaration shall cause the details of the termination to be published immediately by such means of communication considered most likely to notify the population of the area affected.
19. Bylaw No. 205 is hereby rescinded.

This By-law comes into force on the day it is finally passed.

Read a third time and finally passed this 12th day of November, 2008.
